### Video Training For Notaries on Absentee Ballots

With North Carolina's primary coming up next Tuesday and the general election slated for November 3rd, many North Carolinians will be voting by absentee ballot this year.

If you don't know already, North Carolina's absentee voter application and certificate are required to be witnessed either by two witnesses or by you -- one notary.

We sat down with Ozie Stallworth, Director of Electronic Notarization and Notary Enforcement here at the NC Department of the Secretary of State, to walk us through your role as a notary in the voter absentee ballot process.

## **Satisfactory Evidence of Identification**

As a notary, your number one job is to make sure you can positively identify the person coming before you requesting your services. Establishing the identity of the principal signer is foundational to the integrity of the notarial process and should never be taken lightly. This not only prevents fraud and forgery, but it protects you as a notary from committing any violation that could potentially cause you headaches down the road.

There are three statutory methods notaries may rely on to establish the identity of the principal or subscribing witness: personal knowledge, credible witnesses, or satisfactory evidence of identity.

Today, let's take a peek at Satisfactory Evidence of Identity:

If an individual appears before you, and you have never seen him or her before, you may rely on a form of identification known as "satisfactory evidence." [10B-3(22)].

Satisfactory evidence includes one current federal or state issued identification card with a picture of the principal's face and their physical description or signature. Sample forms of acceptable identification include:

- State driver's licenses
- Passports
- Retired or dependents military ID cards
- Cards issued by recognized state tribal agencies

What forms of identification are NOT acceptable?:

- Social Security cards
- US Passport cards
- Matrícula consular cards
- Credit cards

- Newer active duty military ID cards (per page 31 of the Manual, the newer military ID cards cannot be used because the signature and physical description are embedded in a computer chip)
- Temporary driver's licenses





### **Find A Notary**




## **NC Notary Facebook Group**

#### **Fun Facts About March Madness!**

To get everyone ready for tournament tip-off time, we found some Fun Facts about March Madness (courtesy of Fox Sports) that will get you pumped up for some hoop action:

- What are the odds of filling out a PERFECT bracket? Answer: One in 9,223,372,036,854,775,808 (that's quintillion).
- It's been a long tradition that the tournament champions have cut down the nets to take home, but since 1986, the winning school has also been given the hardwood court, too. Many athletes sell or auction off pieces to their fans.
- The oldest coach to win a title was Jim Calhoun in 2011 at the age of 68. The title of the youngest coach belongs to Emmett McCracken who led Indiana to the championship in 1940 at the age of 31.
- Kansas City, Missouri has hosted the most Final Fours to date with 10 since 1953. Indianapolis can overtake that mark in 2035. It is now an official NCAA rule that the Final Four take place in Indianapolis (NCAA HQ) every five years. The city has hosted six times already.
- AT&T Stadium (home of the 2014 Final Four) with a capacity of 80,000 is the largest stadium to ever host a Final Four.
- The record for most overtimes in a single game is four, and it happened twice, once in 1956 and again in 1961.
