### Instructions for Filing

## ARTICLES OF REVOCATION OF DISSOLUTION FOR A NONPROFIT CORPORATION

(Form N-07)

- Item 1 Enter the complete name of the corporation exactly as it appears in the records of the Secretary of State.
- **Item 2** Enter the effective date of the dissolution that is now being revoked.
- **Item 3** Enter the date the revocation of dissolution was authorized.
- **Item 4** Check either a,b,c, and/or d, according to the manner in which the dissolution was revoked.
- **Item 5** See Form
- Item 6 The document will be effective on the date and at the time of filing, unless a delayed date or an effective time (on the day of filing) is specified. If a delayed effective date is specified without a time, the document will be effective at 11:59:59 p.m. on the day specified. If a delayed effective date is specified with a time, the document will be effective on the day and at the time specified. A delayed effective date may be specified up to and including the 90<sup>th</sup> day after the day of filing.

#### **Date and Execution**
